Jerrold Schecter is an author and a journalist with extensive firsthand experience in Russia, Japan, China, and Southeast Asia. He began his career with the *Wall Street Journal*, and then spent eighteen years with *Time* magazine, serving as a foreign correspondent, bureau chief in both Tokyo (1964–68) and Moscow (1968–70), and White House correspondent and diplomatic editor (1973–77). While based in Moscow, he traveled extensively in the Soviet Union and Eastern Europe; he was instrumental in the acquisition of Nikita Khrushchev's memoirs and oversaw their preparation for publication. In 1977 Schecter was invited to join President Jimmy Carter's White House Staff by National Security Adviser Zbigniew Brzezinski. He served as associate White House press secretary and spokesman for the National Security Council until 1980. During the 1980s, Schecter was a corporate officer with Occidental Petroleum Corporation, served as Washington editor for *Esquire* magazine, and returned with his family to Moscow in 1987 to report on glasnost and perestroika (an experience that was the subject of a book and a PBS television documentary, both titled *Back in the USSR*). From 1990 to 1994 he was a founding editor of *We/Mbl*, an independent Russian-American weekly newspaper, started by the Hearst Corporation and *Izvestia*. Schecter's many books include *Khrushchev Remembers: The Glasnost Tapes* (co-translator and editor, 1990); an award-winning biography of Soviet colonel Oleg Penkovsky, *The Spy Who Saved the World* (1992); and *Special Tasks* (1994), written in collaboration with former Soviet spymaster Pavel Sudoplatov.
