**Helena Cobban** is a writer and researcher with twenty-five years' experience of writing about Middle Eastern affairs, and an adjunct scholar at the Middle East Institute in Washington, D.C. This book builds directly on experience she gained as a Middle East-based correspondent in the 1970s, and on research she did for her 1991 book, *The Superpowers and the Syrian-Israeli Conflict*, and her 1997 monograph, *Syria and the Peace: A Good Chance Missed*. In the early 1990s, Ms. Cobban spent two years on the directing staff of the nongovernmental group, the Initiative for Peace and Cooperation in the Middle East. There, she helped initiate a pathbreaking effort at building common ground among citizen-participants from many Middle Eastern countries, including Syria and Israel, on a broad range of issues connected to peacebuilding.

Fluent in French and Arabic, Ms. Cobban is a member of the Middle East Advisory Committee of Human Rights Watch, of the International Institute for Strategic Studies, and the Editorial Advisory Board of the *Middle East Journal*. For many years now, she has contributed regular columns on global affairs to the *Christian Science Monitor*, and to the London-based daily, *Al-Hayat*. Her numerous other publications include a book on the Palestinian Liberation Organization (1984), and an award-winning country study of Lebanon (1985). In early 2000, the University Press of Virginia will be publishing her next book, *The Moral Architecture of World Peace*.
