## About the Authors

**James E. Goodby** is currently senior research fellow at MIT and senior fellow (nonresident) at the Brookings Institution. He has taught at Carnegie Mellon, Stanford, and Georgetown Universities and held the Payne Distinguished Lecturer chair at Stanford during 1996–97. He has written many articles on Europe and Northeast Asia; is the author of *Europe Undivided*, a book on U.S.-Russian relations; and has edited or coedited four other books on U.S.-Russian relations. Entering the U.S. Foreign Service in 1952, he rose to the rank of career minister. His many assignments include deputy to the special advisor to the president and secretary of state for the Comprehensive Test Ban Treaty, 2000–01; special representative of President Clinton for the security and dismantlement of nuclear weapons, 1995–96; chief negotiator for nuclear threat reduction agreements, 1993–94 (the Nunn-Lugar program); head, U.S. delegation, conference on confidence- and security-building measures in Europe, 1983–85; vice chair, U.S. delegation to START I, 1982–83; ambassador to Finland, 1980–81; deputy assistant secretary in the State Department's Bureau of European Affairs and Bureau of Political-Military Affairs, 1974–80; and member, the secretary of state's policy planning staff, 1963–67. He is the winner of the inaugural Heinz Award in Public Policy, the Commander's Cross of the Order of Merit of Germany, and the Presidential Distinguished Service Award. He was named a distinguished fellow of the United States Institute of Peace in 1992. The Stetson University College of Law awarded him an honorary doctor of laws degree in 1996.

**Petrus Buwalda** was born in the Netherlands and studied at the University of Groningen and at the Institut des Sciences Politiques of the

University of Paris. He entered the Dutch foreign service in 1951 and, after several postings abroad, worked in the directorate for NATO affairs in the Foreign Office in The Hague from 1960 to 1964. After postings as political counselor in Washington and Belgrade he was named deputy permanent representative of his country to NATO in Brussels in 1973. Appointed ambassador to Egypt in 1979, he was named head of the Netherlands delegation to the European Disarmament Conference in Stockholm in 1984 and concurrently served as ambassador to Sweden from 1985. From 1986 to 1990 he was Netherlands ambassador to the Soviet Union in Moscow, representing also the interests of Israel. He ended his diplomatic career as head of the Netherlands delegation to the summit of the Conference on Security and Cooperation in Europe in Paris in November 1990.

Ambassador Buwalda was a visiting scholar at the Woodrow Wilson Center in Washington in 1993. In 1997 the Wilson Center Press published his book, *They Did Not Dwell Alone: Jewish Emigration from the Soviet Union, 1967–1991*.

**Dmitri V. Trenin** has been deputy director of the Carnegie Endowment's Moscow Center since 1997 and co-chair of its Foreign and Security Policy program since 1994. Until his retirement in 1993 as lieutenant colonel, Trenin served for twenty-one years in the Soviet and Russian Armed Forces. His postings included serving in Iraq with the military assistance group, in East Germany as a liaison officer with the Western allies, in Switzerland with the USSR INF/START delegation, and in Italy as a senior research fellow at the NATO Defense College. He also taught area studies at the current Defense University in Moscow. From 1993 to 1994 Trenin was a visiting professor at the Vrije Universiteit Brussel, and from 1994 to 1997 a senior fellow of the Institute of Europe, Russian Academy of Sciences.

Trenin received his Ph.D. in diplomatic history from the Academy of Sciences' USA-Canada Institute in 1984. His recent publications as author or editor include *The End of Eurasia; Russia and the European Security Institutions; Kosovo: International Aspects of the Crisis; Russia's China Problem; Baltic Chance: The Baltic States, Russia, and*

*the West in the Emerging Greater Europe; Commonwealth and Independence in Post-Soviet Eurasia; and Russia in the World's Arms Trade.*

Trenin is member of the International Institute for Strategic Studies and of the Russian Association of International Studies. He serves on the editorial boards of *International Politics*, *Pro et Contra*, and *Baltiiski Kurs*.

**Yves Pagniez** was leader of the French delegation to the Helsinki Summit of the Commission on Security and Cooperation in Europe in 1992. In his distinguished career as a diplomat with the French Foreign Ministry, Ambassador Pagniez served as ambassador of France to the Soviet Union and to the former Yugoslavia. He also served as permanent representative to the United Nations in Geneva and as deputy director for political affairs at the Ministry of Foreign Affairs.
