
PREVENTING ELECTION VIOLENCE THROUGH DIPLOMACY

Why do efforts to prevent election violence succeed in some cases yet fail in others? Focusing on three case studies of countries with a history of election violence, *Preventing Election Violence through Diplomacy* identifies the key dimensions of preventive diplomacy to prevent or reduce election violence. Drawing on personal experience, the literature, and expert interviews and roundtables with academics and practitioners, Pokharel highlights conditions for the success and the failure of preventive diplomacy, offering recommendations to the international community for maximizing the efficacy of this unique tool.

Bhojraj Pokharel is an internationally recognized expert on organizing elections in conflict and postconflict environments. As head of Nepal's Election Commission from 2006 to 2009, he was a key architect of the first constituent assembly elections

after the peace deal that ended the country's decade-long conflict. He has twice been appointed by the Secretary-General of the United Nations to serve on high-level panels—for Bangladesh's 2008 parliamentary elections and for South Sudan's referenda process in 2010–11. Currently a member of the Kofi Annan Foundation's Electoral Integrity Initiative steering group, Pokharel was a 2017–18 Jennings Randolph Senior Fellow at the United States Institute of Peace, where he researched and wrote *Preventing Election Violence through Diplomacy*.

Summary

- For decades, Pakistan has been closer to Saudi Arabia than to Iran, but successive Pakistani civilian and military leaders have pursued a more even-handed foreign policy to avoid being perceived as pro-Saudi or anti-Iranian.
- In 2015, Pakistan resumed relations with Iran after a 10-year hiatus as a military campaign in Yemen against Houthi forces. Such a move requires Pakistan to navigate its relationship with Saudi Arabia, which has been forced to take a hard line on the Middle East.
- Following the worsening in Saudi-Iranian relations in January 2016 after Saudi Arabia's execution of a prominent Shia cleric, Pakistan's attempts at double diplomacy and mediation were clear evidence of its increasing role as a regional power broker in the Middle East.
- As the Saudi-Iranian rift deepens, analysts have tried to assess its country impact. It is the country's foreign policy toward Saudi Arabia, close military and economic ties, and the fact that Pakistan likely would choose Saudi Arabia over Iran, should the forced to pick sides.
- Economic ties between Iran and Pakistan have flourished since the conclusion of the Joint Comprehensive Plan of Action on Iran's nuclear program in 2015. However, the US decision to withdraw from the agreement in 2018 could lead to a decline in the Iran-Pakistan relationship.
- In independence in light of Saudi Arabia's role in Yemen, it has been less willing to apply diplomatic leverage on Saudi Arabia in an attempt to shape its regional calculus in the Middle East.

Summary

- Despite a string of institutional innovations and reforms since the EuroMaidan protests, the Revolution of Dignity of 2014-16, Ukrainian activists continue to struggle with institutional reform on the country's accession to the European Union.
- Civilian-led initiatives continue to support anti-corruption reforms as they build trust and legitimacy in the eyes of the public, but they face a number of challenges, including a lack of government support and a lack of political will to implement reforms.
- Ukrainian activists are working to address the institutional reform on the country's accession to the European Union.
- Officials in accountable government suggest that a reform strategy that focuses on closing loopholes and curbing corruption, rather than on increasing the transparency of government processes and decision-making, is the most effective way to address the problem.
- Activists and civil society organizations have directly contacted major anti-corruption reform and program, but their influence and leverage are limited. They are also struggling to secure adequate resources to sustain their work.
- A divergence with respect to the pace and sequencing of change has emerged between anti-corruption activists on the one hand, and change donors and partners working in Ukraine on the other. Better coordinating efforts to achieve common goals is needed.
- International donors and foreign governments should invest in supporting financial support for the government to ensure it has the resources to implement reforms and strengthen its political support structures.

Summary

- Communities in dozens of countries face the challenge of reintegrating, rehabilitating, and reemploying thousands of people who have exited violent conflict.
- This challenge requires an approach that draws on preventing and addressing violent extremism practices to address the social, structural, and cognitive drivers of violent extremism.
- Prevention through often the preferred response, may not be possible in present situations, which are often characterized by a lack of political will, and may require a more holistic approach that includes community engagement.
- Children are victims who require developmentally appropriate physical, emotional, and other forms of support to address their trauma and avoid a life of crime.
- Violent extremism uniquely affects women and sexual and gender minorities, but their unique experiences, motivations, and challenges, without categorically treating women or people of any gender-based orientation as victims.
- Rehabilitation and reintegration strategies help minimize the risk of recidivism. Sustained, positive, inclusive community engagement is needed to address cognitive drivers of "rehabilitation and reintegration," which can contribute to positive individual and societal outcomes.
- Rehabilitation has focused primarily on individuals, but the primary social component to reintegrating families and communities is to establish mutually-revering practices. Creating spaces for personal engagement between them and community members can foster social learning and reconciliation. Such social cohesion, and strengthened relationships.
